


## **Before initiation of work, a Safety Plan....**

- Implement in detail the pertinent requirements of EM 385-1-1.**






## **The AHA ....**

- Sets Control Measures**






## **AHA Points to Remember ...**

**The AHA must be submitted for the work activity *before* the work can begin.**

**The AHA should be submitted *along with* the Safety Plan vice a separate submittal.**


